In order to facilitate the development of the ESTSS into a European umbrella organization for psychotrauma the ESTSS Board has agreed a new fee structure. It is hoped that this will result in an increase in the number of members and a further reduction in membership fees for 2009. This year the standard full membership fees will remain the same. Members of a European society or organisation with a minimum of 20 ESTSS members will be eligible for a reduced ESTSS membership fee as described below. Individual societies can elect to enter an agreement with the ESTSS for corporate membership whereby the individual society collects ESTSS subscriptions from all its members.
